AHBAO Board Meeting Minutes 1-19-2020

Call to Order

President Julie Hedden called to order the regular meeting of the AHBAO Board at 1:19 pm on January 19, 2020 at McMenamin's Old Church Pub in Wilsonville Or.

Roll Call

The following Officers were present: President- Julie Hedden, Secretary- Jill Weicker, and Treasurer - Renay Butts. Board members present: Cassie Richard, Renay Butts, Carol Helton and Cathy Stauffer

Minutes from Last Meeting

All Board members were provided minutes of the last meeting. Cassie moved to accept minutes from last meeting and Carol seconded, motion approved.

Treasurer's Report

Board members had received copies of Treasurer's report which stated there is \$7508.86 in checking and \$24556.55 in savings. Club received \$65 in membership dues, donation of \$750, \$225 convention reimbursement and \$4400 in clinic fees. Expenses included \$1164.63 clinic expenses, \$283.34 fall party expense, \$\$750 scholarship, \$100 to Region IV and \$2025 in convention expense. Jill moved to accept treasurer's report and Cassie seconded to approve it as submitted. The motion was approved.

Standing Committee Reports

- a. Financial/Budget Budget was submitted for 2020. Items changed were as follows: Increase event expense to \$2600, decrease Sunshine expense to \$250.00 and decrease reserves to \$350. Renay requested that the other officers be put on as signors on the checking account for security reason. Jill moved to accept the budget with revisions and Carol seconded. Motion approved.
- b. Nomination/Officer Elections Carol agreed to stay on if by-law revision is approved. Cheryl to be contacted. Sara and Haley to be contacted to see if they are stepping down. No elections were held due to the by-law's revision.
- **c.** Futurity- It was brought to board's attention that current chair person is not a club member which violates club rules. Julie to contact Jared Johnson to see if he plans to join, if not then Renay to take over the position.
- d. Delegates Julie, Carol and Cassie attended the convention in Tulsa. The motions the club had concerns on were all defeated. There was discussion on increasing the funds to the delegates attending the convention. To be further discussed at next meeting.

Julie approved the motion and Cassie seconded. The motion was approved.
- g: Youth: There were 3 youth who sent in entries for year end high point. Love to see more enter.

By-Laws: Motion was made by Jill to revise Article IV to read "Members of the board of directors are elected for a three year term. At the expiration of their term they will be eligible for re-election for a subsequent term if they wish to continue to serve. Carol approved and Cathy seconded. Motion Passed. Jill to send out email to general membership requesting them to vote on the bylaw change.

Spirit America +++//, a palomino affectionally called Tucker, is a horse that has given and continues to give his whole heart for the show arena. Tucker is a National Show Horse and has the drive to help many on his back to succeed in the show arena. He has been a great teacher.

Tucker has a reputation of being a bad boy, which several people who that owned him can confirm. This bad boy was tamed by Karla Moffitt who owned and groomed him to be ridden by many. Tucker learned from Karla's stern approach and her approval with a gentle touch. Under her wing he was leased or loaned too many to be ridden in Arabian Horse Shows, OHSET, 4-H, and used for a lesson horse. Karla counted on Tucker when needing a horse for shows. While showing at a Region 4 he sustained a suspensory ligament injury which nearly ended his career. It took him a year to heal, after which he was ready and willing to work again.

In 2019 Karla signed over Tucker to a woman who has been in love with him for several years. For the first year of ownership Tucker and I got to ride in many Arabian Horse Shows which qualified us to go to Region 4. There were many memorable moments at Region 4, but the best was when Tucker was considered a statue. Karla as always warmed him up before classes. She got off him at the

gate to the main arena and without touching the backed him into the corner. While Karla stood talking with people and not holding the reins, someone thought he was a statue. Tucker is willing to do amazing things for what I affectionately call his, "Alpha Mom", Karla.

2020 is another year where Tucker is in amazing health, sound, and ready for a year filled with Arabian horse shows and another Region 4. My skills have grown and I am proud to be on 25 years old Tucker's back. As long as Tucker is willing and sound enough to show he will have the opportunity to continue his career. Tucker is no longer just a show horse, he is a Heilman family member.

Got to go. My horse is calling!

AHBAO Recreational Rider Program

The Recreational Rider Program (RRP) awards AHBAO amateur and youth riders for every hour that they spend riding or driving an Arabian or Half-Arabian/Anglo-Arabian horse in non-competitive activities.

The Arabian Horse Breeders Association of Oregon (AHBAO) is committed to recognizing and rewarding the riders who work with and enjoy Arabian and Half-Arabian/Anglo-Arabian horses-in all types of non-competitive riding and driving.

The best part of the RRP is that the type of riding does not matter as long as it is in non-competitive! Whether you use an Arabian or Half-Arabian/Anglo-Arabian horse to trail ride, do ranch work, participate in parades, take riding lessons, train under saddle or just ride or drive for pleasure, you can now be recognized and awarded for what you love most.

Starting in 2020, RRP members are eligible to win a Year-End High Point Trophy. Only one person can win so start logging your hours today.

Program participants are defined as an individual rider, not a specific horse and rider combination. This means that as a rider, you may ride any number of horses, regardless of whether you own them or not, as long as they are all Arabians or Half-Arabian/Anglo-Arabians registered with AHA.

NOTE: Participation in any AHBAO program requires a current membership with AHBAO.

Only the following activities are recognized:

Trail Riding Parades Riding Lessons Training under saddle Ranch work Demonstrations Pleasure riding Pleasure driving

Points Earned as follows: For every full hour logged per event/day you receive 1 point. For a half hour logged you receive ½ a point. Any less than a half hour logged is excluded.
