- Participants can sign up for a <u>maximum</u> of 1-AM session (9 AM-12 Noon) and 1-PM session (1PM-4PM) with each clinician. (May <u>not</u> sign up for 2 sessions with the same clinician.)
- Each session is limited to 12 participants/clinician.
- Participants choose order of discipline sessions. Sessions assigned to participants on a first-come, first-served basis based on availability.
- Clinic fees-\$100/session. Includes breakfast snacks and lunch

Showmanship clinic presented by Savannah McGuire. How do you prepare a horse to show in showmanship? How do you set up your horse in showmanship? What does a perfect haunch turn look like? How do you get your horse to do one?
